Note:-

A. The learners already enrolled in the current recognized programmes shall be allowed to complete the programmes in the laid down manner as per the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.

C. Programmes under the ambit of Regulatory Authorities have been considered on the basis of communication/recommendation received separately from respective Regulatory Authority. In case of approvals/recommendations received from Regulatory Authority, HEI shall abide the conditions such as number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.

D. Higher Education Institution shall write 'UGC entitled as per University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment(s)' instead of 'UGC recognized' at all places.
